New Business:

A.) Logos Report

B.) COSC (Committee of School Councils) Report

C.) ASCA Update

The Alberta School Councils Association (ASCA) is the provincial voice of parents through school councils and is one of five provincial education partners providing input on education to the Minister, Alberta Education and each other. The other 4 are the Alberta Teachers' Association (ATA), the Alberta School Boards Association (ASBA), the College of Alberta School Superintendents (CASS) and the Association of Alberta School Business Officials (ASBOA). ASCA sits on the major committees and provides input into education initiatives and ideas, both to Alberta Education and to their partners.

ASCA is funded in 3 ways:

PD sessions.

Membership fees – EIPS buys memberships for each school council. This funds ASCA's Board of Directors to advocate on behalf of the members. Alberta Education Grant – This buys the membership services that ASCA provides to support school councils, ie. staff to answer questions and coordinate

Miscellaneous – This is a very small portion of fee for services (when fundraising societies want a session as ASCA is not funded for that) or conference fees, resource gallery, etc.

A few years ago, there was a change from a 3 year grant to a 1 year grant. The Alberta Education Grant ran out June 30 and ASCA has not yet received word whether the new grant will be successful. As such, ASCA would need to stop providing sessions and services after October.

ASCA is encouraging school councils to contact their MLA and the Minister of Education and share their story if they have found ASCA helpful.

D.) School Council Engagement Task Force

Throughout the school year, ASCA will send questions on a pre-determined topic to bring to school councils for their discussion and feedback. By participating, it is another way for Westboro School Council parents to communicate and help advocate at a provincial level.

Krystal Gibson started the conversation about the September 2019 request for input regarding "Choice in Education". We will be submitting our feedback as a school council to ASCA by November 2nd.

E.) What can parents do to support teachers in the class room?

Krystal led the discussion on how parents can provide more in-class support to our teachers during this time of budget uncertainties. Mike will talk with staff about ideas of how they could utilize more parent volunteers besides fieldtrips. He also encouraged parents to contact Erin Tomkins, our literacy consultant, to get more information about the training for providing small group reading support.

F.) Open Questions

After the spring online survey and discussion at the April 24th school council meeting, what was the decision about how to pay for fieldtrip fees? Fieldtrip fees for this school year will be paid in full up front. A letter to parents will be going home in October showing each students' list of fieldtrips for the year.

As a follow-up from the April 24th school council meeting, will families be able to view Friday morning video announcements outside of the school? Mike has taken over the video announcements for this year and is developing his process. He is working towards having that option in place.

What work was done on the school this summer? Furnaces were replaced.

Do we have a school policy on the use of YouTube during class time? No.

Does the personal device policy stay in effect during offsite fieldtrips? Yes.

Is Battle of the Books going to be offered again as a school activity? Yes.

Is the October grade 5 blanket exercise done with parent permission? Yes.

Where does the conversation start to make the grades 5/6 gate access in and out of the west playground a safer walking surface? Concerns can be emailed to Mike who will pass it on to the appropriate maintenance agencies.

Is a hand-held game considered a personal communication device? If the device can connect to the internet, it is considered a communication device. Parents will need to use discretion for items like this.

School Reports:

A.) Admin Report

Mike Lastiwka reviewed portions of the School Education Plan and also talked about building resiliency in our Westboro students this year.

Chantel Werner shared the following report.

- Westboro has 3 new staff Mrs. Wieler is the 5L teacher and Mrs. Matyjanka and Mrs. Sutton are education assistants in the PLACE classroom.
- Mrs. White is running a student contest to name the dragon in the new mural in our school library.
- First fire drill of the year went well.
- Welcome Back BBQ was very successful.
- When the office marble jar is filled, the entire school will take a fieldtrip to attend a Sherwood Park Crusaders hockey game scheduled for Wednesday, November 6.
- Chantel and the grade 6 teachers are working together on a weekly reading workshop.
- We are no longer having Monday afternoon circles. Instead, 2 grades at a time will have either Mike, Chantel or Dianna Graziano (school counsellor) cover the classroom once per week to allow teachers prep time.
- Across grade activities will be happening once a month.
- Chantel and Mike are organizing a student council with grades 5 and 6. Each teacher was responsible for the process to choose student reps.
- Chantel is very excited to have 40 AMA Patrollers sign up!

B.)Teachers Report

Leah Canning, our 3R teacher, shared the following report.

- Erin Tomkins has organized another family literacy event on Wednesday, October 9th from 6:00-7:15pm. This year it is open to students of all grades and their families and so far, she has 150 participants signed up. The event includes a book swap and Erin will also be accepting book donations.

C.) Trustee Report

The school year began for the trustees on the Thursday before the long weekend with the trustees cooking breakfast for the central Administration staff followed by our organizational meeting for the year.

We have met a number of times in September including our annual board planning Retreat which we just completed September 17 and 18th. Major discussion points during these days included facilities and student populations including Sherwood Park and Fort Saskatchewan which both face challenges with growth in the communities in coming years.

In our meetings we have reviewed the current the new policy for the use of electronic devices which seems to be working very well we are getting good replies from parents and school administrators. We are also getting inquiries from many other boards in the province and across Canada for information on the policy as they want to create one for their school divisions.





ASCA School Council Engagement Task Force - September 2019 REQUEST FOR INPUT

Thank you for participating in the *School Council Engagement Task Force (SCETF)* for the 2019 – 2020 school year.

The feedback your school council parent representative compiles and submits to the ASCA is greatly appreciated by the Board to assist in their considerations on education issues in Alberta.

The Board utilizes information gathered to inform the advocacy work of the association. This may include advising at external committee meetings, sharing with appropriate Ministries or provincial education organizations, and the potential for Board sponsored Advocacy Resolutions.

Request for input regarding "Choice in Education".

Background/context:

It is known that the Minister of Education will begin work on the promised *Choice in Education Act*, for tabling in the spring of 2020. The Minister has indicated that consultations will be forthcoming, and it is highly anticipated that ASCA will be asked to contribute to consultations related to the contents of the *Act*.

At this time, ASCA has no distinct Advocacy Policies that represent Member perspectives related to *Choice in Education*. It is also possible that ASCA Member School Councils are not aware that greater access to alternative programs, like languages, sports, and other disciplines, is not likely what is intended with the *Choice in Education Act*.

The United Conservative Party (UCP) outlined in their <u>election platform</u> (page 57-60) a detailed <u>commitment to education</u> including one of 13 items, the following which indicates:

10. Affirm parental choice through a Choice in Education Act.

Alberta has a strong legacy of diversity in education. A UCP government will uphold the established right of parents to choose the education setting best suited for their children including: public, separate, charter, independent, alternative and home education programs.
