She has volunteered to lead the event again next year! We had more attendance this year than last but support for all 3 of the fundraisers (gift basket raffle, silent auction, photo booth) were much lower than in past years. We may consider holding just a dance next year as a way of building community rather than using the event as one of our two major fundraisers. Approximately \$2000 was raised and will be used towards Westboro Parents Group events and activities for the 2019-2010 school year.

E.) Executive Transition & Event Committees

Krystal explained that at this time, we are looking for a parent volunteer to put their name forward for the Westboro Parents Group Vice Chair position and possibly the Treasurer position. An idea was discussed about a compostable bag sale fundraiser for next year. Debbie will research preliminary details and include it in the May 30th AGM discussion of which fundraisers we plan to commit to for the next school year.

F.) Barred Instruments

Jacquie Surgenor provided an update on the steps taken thus far to help the school purchase new barred instruments for our music room. Fundraising for this school request began in the fall of 2017 and Westboro Parents Group has been able to allocate \$10,500 – about half of the cost of the replacement instruments. In May 2018, we applied for a matching provincial grant but were denied in December. Since then, we have secured a \$5000 donation from Strathcona County Council Priority Funds. Jacquie is submitting a \$2500 County Clothesline grant application next week which we should hopefully know in June if we are successful. Mike has said the school could provide up to \$2000 but the remaining amount still needs to be provided through fundraising efforts. A bottle drive has been organized for next month to help

with this. We still hope to be able to purchase these barred instruments in June to be ready for use in September.

G.) Open Questions

It was shared that a bottle drive has been organized for Tuesday, May 21st from 8:15am to 3:45pm in front of our school. Families are encouraged to start saving their bottles for this final fundraiser and to drop them off at the school on this day. All proceeds will go towards the purchase of new barred instruments for our music room.

The year end staff appreciation lunch is scheduled for Wednesday, May 15th. We always appreciate family support for this event so watch for letters coming home with students to see how you can help out!
